- Interstate 5 to Exit 116, Mounts Road/Old Nisqually, at end of ramp turn LEFT onto
- Nisqually Rd (Old Pacific HWY) stay on it until it ends, turn LEFT onto
- Hwy 510 (St. Clair Cut-Off Rd SE), travel 1/4 mile, turn RIGHT onto
- Meridian, travel South several miles through the stop sign at Yelm HWY,
- Continue on Meridian through a left turn and a right turn,

PackLeader Farm Herding Ranch Dog Trial (HRD) March 16, 2012

GENERAL RULES:

- Time 20 minutes.
- In all elements, quiet efficient stock work is essential.
- All elements must be accomplished prior to moving on.
- All gates may be open/closed at the Handler's discretion (unless specified); however, time will not
 end until all gates have been restored to their original/starting position.
- Ties breakers: 6. Sort and Pen, 2. Fetch/Drive, Time

STARTING SET- UP:


- All gates are closed, except Pens 2 & 3 to Narrow Alley, which are open.
- 10 sheep in Side Pen, 30 sheep in groups of 5 in Alley C/D, 20 sheep in reserve.
- 1. **PENS 10 PTS.:** Take sheep from 2 designated pens in Alley C/D, combine sheep and move them through Pen 2 into Arena A, and move to Handler Post. Exercise ends when the sheep arrive at the Handler Post.
- 2. **FETCH/DRIVE 20 pts.:** Fetch/drive the sheep from the Handler's Post through free standing Obstacle and on to the Set Out Post. Exercise ends when sheep arrive at the Set Out Post.
 - **HRD I -** Handler may take any position.
 - HRD II Handler must remain at the Handler's Post until the stock clear Obstacle 1.
 - HRD III Handler must remain at the Handler's Post until the stock reach the Set Out Post.
- 3. GATHER HRDI & II 15 pts.; HRDIII 25 pts.:

HRDI & II: Recall dog and move to the position appropriate for the team's level. Gather the sheep to the Handler, and then proceed to Pen 2. Exercise ends when the sheep have reached the gate to Pen 2.

HRDIII: Move to the handler's post and recall dog. Gather sheep and move them back through the obstacle to the handler then proceed to Pen 2. Exercise ends when the sheep have reached the gate to Pen 2.

- HRD I Dog at 75 feet from sheep, Handler within 15 feet of sheep.
- HRD II Dog at 150 feet from sheep, Handler ½ way.
- HRD III Handler and dog 150 feet from sheep
- **4.** NARROW ALLEY 10 pts.: Dog will hold the stock off Pen 2 gate, allowing the handler to freely open the gate. Move stock through Pen 2, down narrow alley, through Pen 3 and release them into Arena B. Exercise ends when Arena B Gate is closed.
- **5. PENS/FOOTBATH 15 pts.:** Remove sheep from Side Pen, move sheep through Pen 3 into the Footbath Alley, through the Footbath and toward Pen 4. Return to Arena B, remove sheep and pen in Side Pen. Exercise ends when the Side Pen gate is closed.
- **6. SORT AND PEN 20 pts.:** Return to the footbath Alley, gather sheep, move through the footbath. Sort sheep into 2 groups of 5 sheep and pen in original pens in Alley C/D. Sort may be done anywhere from Pen 3 to Pen 2 or in the C/D Alley. Exercise ends when sheep are penned.

Time stops when **ALL** gates have been restored to their original/starting position.



Fido's Farm Herding Ranch Dog Trial (HRD) March 17, 2012


GENERAL RULES:

- Time 20 minutes
- All elements must be attempted prior to continuing
- All gates must be closed and latched unless otherwise stated
- Dog must hold sheep off all gates
- Tie breakers: 2. Hold and Controlled Movement, 4. Gather and Fence Line Obstacle, Time

STARTING SET UP:

- 30 sheep in Barnyard.
- All gates shut and latched except Round Corral gate which is to remain open.
- 1. SORT- 10 pts.: Time starts when gate into Barnyard is opened. Gate sort 5 sheep into Gate Box.
- 2. HOLD AND CONTROLLED MOVEMENT 30 pts.: Dog and handler pass through Gate Box and open the gate to Main Alley without disturbing the sheep. Dog to hold sheep in the Gate Box while handler opens the Sorting Yard gate. Move sheep into Sorting Yard then to Test Arena. Exercise ends when Test Arena gate is closed.
 - HRDI Handler may enter Gate Box
 - HRD II Handler to remain outside of Gate Box
 - **HRD III** Handler to remain at Sorting Yard Gate.
- 3. DRIVE/WEAR 20 pts.: Move sheep through Panel Obstacle at bottom of arena and settle them, recall dog to Round Corral Gate
 - HRDI may move with sheep throughout exercise
 - **HRDII** handler may move halfway to panels
 - HRDIII handler to remain at Round Corral gate
- 4. GATHER & FENCE LINE OBSTACLE HRD I & II 20 pts.; HRDIII 30 pts.: Gather sheep, move sheep through corner L Chute entering the end closest to Round Corral Gate, move sheep into Round Corral. Exercise ends when sheep are in Round Corral.
 - HRDI place dog half way to sheep. Handler may move to within 15 feet of sheep, Handler may move with sheep for remainder of exercise
 - HRDII place dog at Round Corral Gate. Handler may move half way to sheep for Gather, Handler to remain at entry to L Chute until sheep exit Chute.
 - HRDIII send dog from Round Corral gate. Handler will remain at gate until sheep enter the Round Corral.
- **5. PENNING V AND REPEN 10 pts.:** Move sheep into Big Arena, pen sheep in Penning V. Repen into Gate Box. Time ends when Gate Box gate is latched.


Frog's Breath Herding Ranch Dog Trial (HRD) March 18, 2012

GENERAL RULES:

- Time 20 minutes
- All elements must be attempted prior to continuing
- Tie breakers: 6. Open Field Work, 3. Drive, Time

STARTING SET- UP:

- There will be a set of (5) five sheep in Field 2 and Pen A.
- All gates will be closed and must be closed at the completion of the run.
- 1. **GATHER 20 pts.:** Time and the exercise begin when the handler opens the gate. Outrun lengths 60' for HRDI, 120' for HRDII and III. Take the sheep to the feed pan and put grain into the pan. Call the dog off the sheep, and move to the appropriate Handler's Post. Gather and move sheep to the gate area. Exercise ends when handler reaches the gate area.
 - HRDI will put the dog at the Handler's Post closest to the feed pan and may move to within 15' of the sheep for the gather.
 - **HRDII** dogs will use the Handler's Post closest to the gate. The Handler may move as close as the HRDI Handler's Post.
 - **HRDIII** dogs will begin their gather from the post closest to the gate. The handler will remain there for the entire gather.
- 2. GATE WORK 10 pts.: Move the sheep into Field 1. The dog must hold the stock off the gate while it is being opened and cover the sheep after they have entered Field 1. The exercise ends when the gate is closed and latched.
- **3. DRIVE 20 pts.:** Drive the sheep through free standing obstacle, turn right and put them into the appropriate Pen A or C. The exercise ends when the Pen gate is closed.
 - **HRDI** may accompany dog and sheep. Put the sheep in Pen C.
 - HRDII & III will remain at the gate until sheep pass through or past free standing obstacle. Then they are free to move. HRDII will put the sheep in Pen C. HRDIII will put the sheep in Pen A.
- **4. SORT -** <u>HRDIII only</u> **10 pts.:** Using the race, sort the five sheep that were in Pen A into small area next to race. Let the sheep that you just added to Pen A straight through the race into the barn. (Sheep will be marked.) Exercise ends when the last sheep clears the race.
- **5. PEN 10 pts.:** Remove the sheep from Pen A. Cover the sheep while the gate is being closed. Exercise ends when the gate has been closed and latched.
- **6. OPEN FIELD 30 pts.:** Move the sheep into the area formed by the cones (approximately 100 feet wide), move the sheep the length of the field, through the panels to the gate at the far end of the Field 1. Pen the sheep in Field 2. Time ends when the gate is closed.
 - HRDI may move with the sheep
 - HRDII may move anywhere outside the corridor formed by the cones.
 - HRDIII will move along the fence for the entire exercise, doing a cross drive
