Directions from Tacoma:

Take the highway 16 / Bremerton exit (off I-5). Go across the Narrows Bridge and past Gig Harbor. Take the Purdy /Shelton exit. It's about nine miles from the narrows bridge. Go left at the first traffic light. You will go about 6 miles or so and the road will kind of Y, keep going straight (the right turn will take you to Shelton and you DON'T want to go that way). You will go through a town called Key Center and then the next little town will be called Home. You will go 3 1/2 more miles after crossing the Home bridge. Make a left on 40th KPS and we are the first drive on the left. Address is 3710 Reeves Road KPS Longbranch, WA We are 18 miles from the stop light in Purdy.
